 - (b) copy of the day-to-day programme you plan to follow during the Tour.
 - (c) photo copy of the Registration Certificate verifying the registration or approval of your Travel Agency with the Government of India.
 - (d) photo copy of your PAN Card(mandatory), GSTIN number and a certificate on the letter head of the company specifying if the company is sole proprietorship/partnership.
- If your agency is private one then TDS will be deducted. Final payment will be made after deducting TDS.
- The school reserves the right to reject any quotation based on reputation of the tour operator.
- No payments will be made for students opting out 10 days prior to the date of departure. Payment intimated within 10 days of departure will be as per actuals, on production of necessary bills/receipts

(e) PAYMENTS

Payments preference is as follows: 50% of the full payment will be sent in advance .Full and final payment will be done on receipt of proper bill submitted after the completion of the activity.
